The Union Sports Arena 2010 Adult Spring League is designed for B & C level team entrants looking to play in a friendly, yet challenging and competitive, non-checking, hockey division.

Game Days: Sunday thru Friday nights.

Start Times: between 8:30 to 10:45 PM

- The season will consist of 10 games from Fri. April 9 thru Sun. June 20.
- Any team paid in full by March 31 will have a free 1-hour practice beginning the week of April 5, or a \$200 team fee discount.
- Playoffs will run from Mon., June 14 thru Sunday, June 20 (format to be determined based upon number of registered teams).
- All players must be over 18 years old, born 1991 or earlier.

Please Note:

- All applications must be submitted, with required payment (see below), by March 31, 2010.
- No games will be played Easter Sunday or Memorial Day Weekend.
- USA Hockey equipment rules apply for all Union Sports Arena Hockey programs.
- All players must be registered with USA Hockey (Managers: provide copies of USA Hockey cards or \$40 registration fee per non-registered player.)
- Players from our Fall-Winter League are already covered by USA Hockey.

Individuals: Cost \$275 each

- Individual entrants will play as a team or will be placed appropriately by the Union Sports Arena Hockey Staff.
- Individual applicants must pay in full upon registration.
- Goalies pay \$185.00 as Individual Entrants.

Teams: Cost \$3500

- Maximum of 20 players (including goalies) on roster (USA Hockey rules).
- Team application accepted with a **\$2000.00 deposit, due March 31**. Balance due April 30.
- Team entrants must provide rosters and uniforms.

League Rules:

- USA Hockey rules apply, except where superseded by house rules.
- Fighting penalties, or any other gross misconduct penalty, will result in expulsion from the league for any remaining games in the season.
- For players to participate in playoffs, they must have played in at least 5 of the initial 10 games.
- All games have 15-minute periods. Blue line icing applies.
- Running time for a 6-goal (or greater) differential in the third period.
