Midget / HS Varsity level teams

This program is intended for both Midget level travel teams and High School varsity teams. It is intended to offer these teams an opportunity to practice and play together prior to the start of the Fall hockey season. It is an excellent opportunity to introduce Bantam players to Midget hockey or High School JV players to varsity hockey.

Depending upon enrollment, Union Sports Arena may divide registered teams into divisions in order to provide the most competitive opportunities for all teams.

- The season will consist of 8 games - plus play-offs - from Tues. July 6 to Sun. August 29, 2010.
- Regular games will be played Sunday through Thursday evenings. No Friday or Saturday games, except for play-off games.
- Each team will have 2, 1-hour practices beginning the week of July 5.
- 1 practice will be shared-ice, 1 will be full ice. All practices will be held on weekday evenings.
- Playoffs will run from Thursday, August 26 through Sunday, August 29.
- Playoff format will be determined based upon the number of teams registering.

Please Note:

- All applications must be submitted, with required payment (see below), by June 20, 2010.
- Full equipment is required for all Union Sports Arena Hockey programs.
- This program is intended for current or entering High School students - born 1996 or earlier.
- **All players must be registered with USA Hockey.** (Managers: provide copies of online registration confirmation e-mails, current USA Hockey cards or \$40 registration fee per non-registered player.) All Union Sports Arena Spring League players are already covered.

Individuals: Cost \$230 each

- Individual entrants will be added to existing teams or organized into a separate team.
- Separate teams of individual entrants will be coached by Union Sports Arena staff and will receive team jerseys.
- Individual applicants must pay in full upon registration.
- Goalies pay \$130 as Individual Entrants.

Teams: Cost \$2900

- Maximum of 20 players (including goalies) on roster (USA Hockey rules).
- Team application accepted with a **\$1500.00 deposit, due June 20, 2010.** Balance due by July 18, 2010.
- Team entrants must provide rosters and uniforms.
- Managers / Team Organizers: Don't forget to include your coach and jerseys (about \$30/player) when calculating your-player fee.

League Rules:

- USA Hockey rules apply, except where superceded by house rules.
- Fighting penalties, or any other gross misconduct penalty, may result in expulsion from the league for any remaining games in the season.
- For players to participate in playoffs, they must have played in at least 4 of the initial 8 games.
- All games have 15 minute periods.
- Running time for a 6 goal (or greater) differential in the third period.
